Course Description

H12hr/8 - 12 hour course

Start at a point in the lead out from the lay-by on the north side of the A31, approximately 10 yards east of the Chawton roundabout.

START OF MAIN CIRCUIT. Proceed (Care) to join the A31 and proceed eastward along the A31 to the Holybourne roundabout.

3.17 miles - Take the second exit, keeping on the A31, continue via the Bentley by-pass to the Coxbridge roundabout at the junction with the A325. (Great care needed).

10.038 miles - Circle the roundabout (Check) and take the fourth exit to retrace along the A31 to the Holybourne roundabout. Keep to the LEFT hand lane at the roundabout.

17.053 - Take the first exit, keeping on the A31, continue ahead to the Chawton roundabout. Circle the roundabout taking the fourth exit, to retrace along the A31 passing the start point.

20.095 - Proceed (Care) to join the A31 and proceed eastward along the A31 to the Holybourne roundabout. END OF MAIN CIRCUIT

The finishing circuit is from the Holybourne to Coxbridge roundabouts (the section from 3.17 miles to 17.053 miles where riders must *circle* the Chawton roundabout rather than continue straight ahead).

Marshals referred to in this course description (M1, M2) etc may be provided solely to indicate the course direction. They have no role whatsoever in the risk assessment itself.

Course History

There have been two serious incidents, seven years apart, on a section of the A31 covered by this course, the first was in 2015 and a second in 2022. The driver of the vehicle in 2015 admitted a charge of causing death by dangerous driving. The driver of the vehicle involved with the later incident is currently facing serious criminal charges. There is no suggestion that either of the cyclists involved, nor the course design was in any way at fault.
