Course Description:

Start: On the old A30 just before the bridge over the dual carriage way going over the new A30 outside Honiton approx. 150 metres from the large layby situated on the righthand side of the old A30 (the turn).

Course: Proceed up the old A30 to the T junction and turn right under the iron bridge proceeding through Fenny Bridges past Patterson's X and turn left (Fairmile) and around the green triangle retracing back through Fenny Bridges under the iron bridge turning left down the old A30 turning at the large layby (left) retracing your steps (right) back up the old A30 going past the green triangle.

Finish: Approximately 50 metres past the green triangle on the Fairmile road small layby on the left

HQ: The adjustments to the original course have been made as in the present circumstances it was unfair to use the facilities kindly offered by the Sid Valley CC member the use of the car park and toilets at his industrial unit. Signing on will be in the car park (Smiley's café) with public toilets just of the new A30 at Honiton opposite the Aldi store. Getting to start riders will turn left out of the carpark proceed past the garage to the roundabout and turn right. Then turn left into Heath Park industrial estate past Lidl up to the T junction. Turn right and at the end of the road turn right again. Go over the dual carriage way bridge and turn right to the start. (Approximately just over half a mile).

Traffic Flows: Club 10 on a Wednesday evening starting at 19:00, traffic flows very minimal. Previous assessments of the same roads indicated a traffic flow of 40 vehicles per hour.

No marshal will be in place at the junction, to ensure riders obey the highway code arriving at the give way junction (rider has to give way). The rider makes their own judgement decision based on road safety.
