Courses and roads assessed. LC135	Course local to: High Hesket (A6, between Carlisle and Penrith, approx. 5 miles south J42). 13.6 mile Hilly, Type B Course
Date of assessment/review: 29 January 2019. Approved: 20 March 2019	Name of assessor: Lee Foster, Border City Wheelers.

Course description

START: South end of layby on High Hesket A6 by-pass, just north of direction sign for Ling. Follow A6 south for approx. 6.8 miles passing through Plumpton to the Stonybeck roundabout. Encircle the roundabout, taking 6th exit to retrace along A6 northbound. Follow A6 north to finish adjacent to field gate opposite the start.

Traffic flows

Wide A roads with a roundabout at the southern end. Moderate and well within guidance notes for single carriageway courses.

Course event/history

This is a new Type B (Club) events course (2019), which uses basically the southern end of two approved existing courses (L2512 and L1020). This risk assessment has been adapted from those risk assessments. The L2512 type B course that was approved in April 2005. The L1020 type B course, which is consistent with the southern end of the L2512, but only uses 1 roundabout. It is also is consistent with the southern end type A risk assessment of the L2512 completed by Kevin Hesketh 2018, but again only uses 1 roundabout.

8		Finishing /Return to HQ	Riders continue past the finish along the A6 to the HQ	LOW	Organiser at signing-on inform riders they must not return to the timekeepers or to perform U-turns on the A6.

NOTES:

1. The use of a vehicle for the timekeeper(s) at start and finish is where appropriate and is only identified as an example for the action to be taken.

2. The small junctions or entrances to farms/facilities (garage, eatery, etc) that are not identified in this risk assessment have been considered, however are not considered significant to pose a risk and therefore have not been noted.

3. All rules of the road must be followed as to 'the Highway Code'.

4. This risk assessment shall be made available at the event signing on. By the riders signing on to event sheet they accept all hazards identified on this course and are aware that this is an open road event and that they have a duty of care and courtesy to other road users.
