

## **RISK ASSESSMENT**

Courses and roads assessed. LC1023	Course local to: Beetham – Borwick Lane – Beetham (All on A6)

### **Course description**

Start next to clearway sign at mouth of Paradise Lane, Beetham, then proceed south along A6 for 4.85 miles to roundabout at junction with A6070 and Borwick Lane. Encircle RAB and exit onto northbound dual-carriageway of A6. Continue north, past Beetham, to finish at northern end of lay-by beside the River Bela (approx. 0.2 miles north of start point).

#### **Traffic flows**

For midweek evening cycling club events the traffic flows are very light as the route is almost all in open countryside linking Carnforth with Milnthorpe. Even in daytime on a Sunday (Christmas 10 once a year) vehicle numbers are well within permissible limits for a CTT event as the bulk of north-south traffic between North Lancashire and Cumbria uses the nearby M6.

### **Course event/history**

This is a Type B (Club) events course corresponding to L1023 open event course. The course between Milnthorpe and start of southbound A6 dualcarriageway has been used by the Kent Valley Road Club for midweek club 10-mile time trials since the late 1970s. The proposal to start starting and finish the event further south of Milnthorpe has been prompted by feedback from our turn marshals to make the event turn safer. The acceleration of modern motor vehicles entering a section of dual-carriageway creates a growing safety risk for any cyclist trying to change lanes to reach the safety of the central reservation gap at Snape Lane, where they can turn and retrace north back up the A6. Moving the turn further south to the RAB means riders can stay on the left side of the dual carriageway before filtering onto the RAB with much slower-moving traffic.

9	9.60 miles	Leighton Beck Lane joins A6	Possible traffic joining A6 from Wheatsheaf, Beetham. Good sight lines north and south.	LOW	<b>Organiser</b> to place cycle event warning sign at mouth of junction to alert drivers to cyclists on the A6.
10	10.00 miles	FINISH at at northern end of lay-by next to River Bela	Riders stopping instead of carrying on over rise into Milnthorpe and the event HQ	LOW	<b>Organiser</b> to ensure riders are reminded at signing-on to continue past the finish into Milnthorpe before stopping.

NOTES:

1. The use of a vehicle for the timekeeper(s) at start and finish is where appropriate and is only identified as an example for the action to be taken.

- 2. The small junctions or entrances to farms/facilities (garage, eatery, etc) that are not identified in this risk assessment have been considered, however are not considered significant to pose a risk and therefore have not been noted.
- 3. All rules of the road must be followed as to 'the Highway Code'.
- 4. This risk assessment shall be made available at the event signing on. By the riders signing on to event sheet they accept all hazards identified on this course and are aware that this is an open road event and that they have a duty of care and courtesy to other road users.
