| 1 General requirements | Use of this course would not be practical without road closure. This RA assumes a road closure will be in place. | | | L |
| 2 Before start | Course clear on day. Competitors parking. Competitors riding from HQ and warming up. | L | Organiser to check course is clear on day. Organiser to appoint marshals to supervise parking. Organiser to ensure no warming up on the course once road closure is in force. Organiser to warn riders in programme that prior to road closure warming up will only to be permitted up the course and to advise riders of alternative safe routes to base of hill. | L |
| 3 Start area | Competitors waiting. Low risk with road closure in force. | L | Organiser to prominently display head up sign | L |
| 4 Start | Competitor/holder up falling. | L | No additional measures required. | L |
| 5 On course : | Parked cars | L | Organiser to ensure residents are leafleted before day of event and to leaflet parked cars on the day before the event. Also on the day of the event to attempt to have any parked cars moved and to place a warning to competitors to beware parked cars in programme. | L |

| 6 On course : | Cars straying onto course. | L | <p>Organiser to ensure :</p> <ul style="list-style-type: none"> - Marshals and barriers placed at each side of road. - Limited access from Pinners Close Estate, downhill only, to leave closed road section at bottom of Carr St. This to be firmly controlled by marshals. - Traffic cones to be placed along centre of road from Pinners Close to Start - vehicles to be permitted to cross the course from Callender St to Springwood Lane, again under strict control of marshals. | L |
| 7 On course : | Spectators encroaching onto course between start to Dundee Lane. | L | Organiser to place marshals with whistles at regular intervals to warn of approaching riders, again under strict control of marshals. | L |
| 8 On course : | Spectators encroaching onto course between Dundee Lane to Finish.. | L | Organiser to place team of marshals to control spectators. | L |
| 9 On course : | Wet leaves on course. | L | Organiser to arrange for course to be swept if necessary. | L |
| 10 On course : | Riders returning to car park. | L | Organiser to place notice in programme that competitors must not ride back down the hill and to advise of an alternative safe route. | L |
| 11 On course : | Spectators standing in main road. | L | Organiser to appoint marshals to control spectators. | L |
