General Information

Event HQ

East Hoathly Village Hall next to the church [NOT the usual Sports Pavilion] in Church Marks Lane, East Hoathly BN8 6EQ – Open from 08:00am with first rider off at 09:01 after the clocks have changed.

The back of the hall faces on to South Street about 600 hundred yards from the start and the junction with the A22. There are steps up from South Street opposite Juziers Drive and a path along the side of the hall to take you to the main entrance.

Thank you in advance for not wearing cycling shoes or cleats in the hall.

Please show respect to local residents in the village with no shouting within earshot of houses, considerate parking and no turbo trainers to be used within 50 metres of a domestic property. There have been a number of adverse comments about cycling events in the local Facebook Group, so please take care.

Car Parking

There is limited parking [less than 20 spaces] in the Church Marks Lane car park. There is parking in the 600 yards between the start by the A22 junction and the steps up to the hall opposite Juziers Drive. We were not able to book the Sports Pavilion due to an activity being held there. Please do not use the Sports Pavilion car park.

Live Leader board on smart phones courtesy of ResultSheet – Prize Presentation in HQ

Prize money will be presented immediately after the event in the HQ. As per details below we will be using ResultSheet to provide a live leader board on smart phones and a small monitor in the HQ. Please stay for tea and coffee, and light refreshments, before the prize presentation. If not staying in person to pick up cash prizes you have two weeks to provide the necessary details to the event organiser if you wish to claim the cash.

Race Numbers

Race Numbers will be available at the event HQ. Please collect your number when you sign on. If pinning your number please only use the eyelets, and please do not use additional pins as it tears the number. the cash.

Notice of any additional hazards to be aware of on the course will be displayed next to the signing on sheet.

Start

The start is on South Street 28 yards from the junction with the A22. It is about 600 yards from the steps up to the back of HQ, with path along the side to the main entrance in Church Marks Lane.

Riders Be Aware

Generally the road is in good repair however there are some sections where care must be taken:

Approximately 400 yards after the start the left hand side of the road has a rough section and some holes.

On the return leg, at about mile 7.5 there are a number of holes on the left hand side of the road including some long cracks that have been partially filled in.


Signing Out

Please note that all competitors are required personally to sign the signing out sheet when returning their number. In accordance with CTT regulations, failure to do so will result in the competitor being recorded as DNF.

Please pay attention to the following CTT regulations/recommendations

- **Both Front and Rear Lights must be fitted and working** CTT Regulations now require that "No competitor shall be permitted to start either a Type A or Type B event unless such competitor has affixed to the front of their machine a working front white light and to the rear of their machine a working rear red light; either flashing or constant, that are illuminated and in a position that is clearly visible to other road users. **NOTE THIS WAS A NEW REGULATION FOR 2022**
- **Helmets** CTT regulations now require the use of a helmet that meets internationally accepted safety standards for all competitors. **NOTE THIS WAS A NEW REGULATION FOR 2022**
- **Parental Consent Forms** Under 18 age entries must download and complete and have a signed parental consent in order to compete. The completed form must be brought along to the signing on along with your helmet and lights. No helmet, no lights, no parental consent, no ride.
- **Warming up** Competitors are requested not to warm up on the course after the first rider has started.
- **Competitors' Vehicles** No vehicles, except those of timekeepers and event officials, shall be parked in the vicinity of the start or finish.
- **Official Observers** Official observers will be stationed around the course.
- **Results** No times will be given out at the finish.
- **Audio Equipment** Competitors must not use ANY audio equipment except prescribed hearing aids. A competitor in breach of this regulation shall be disqualified. Competitors must not use a mobile phone while mounted on their machines.
- **Race Numbers** The race number is made of fluorescent material which is an important safety feature. It is essential that it is placed correctly for maximum visibility to other road users and of course the timekeepers. No time may be recorded if number is not correctly positioned.
- **Signing Out** Please note competitors must return to the event HQ either during the event or within a reasonable time after the last rider has finished the event and must return their race number and sign the official signing out sheet. A rider who fails to so sign the official signing out sheet shall be recorded as DNF.

If anyone has a query about their time please bring it to our attention as soon as possible so the timekeepers can check if your query is valid. The time keepers will do an initial check at the HQ and confirm the prize winners to be announced in the HQ presentation.

Time keepers will double check times in the afternoon before the final result is published on the CTT web site.

ESCA Prize Money pay out, and donations to charity

Several ESCA affiliated clubs donate funds to a charity, with riders that win prize money adding their winnings to the pot. Subject to the number of entries over the season ESCA will, as in 2022, be selecting a charity e.g. Air Ambulance Kent Surrey Sussex, who have airlifted injured cyclists to hospital, and making an end of season donation. Any ESCA Prize winner that wishes to donate their winnings to the ESCA pot can let the Event Organiser know. Any unclaimed prizes will also go into the pot.

Cash prizes for the top three riders in each category will be presented in the HQ straight after the event. The result sheet will list all the cash prize winners and any that have left early will be advised that if they wish to claim their prize money they need to contact the Event Organiser to arrange means of payment no more than two weeks after the event with the necessary details provided for payment. The preferred method of payment is by PayPal. Otherwise please give your account number and sort code and exact name of the holder(s) so that the account details can be verified for a BACS transfer.



TQ513162	4th exit and retrace on A22 through Golden Cross and Whitesmith to FINISH at red arrow at second drain past field gate on East Hoathly by-pass just before first footpath crossing and 334 yards past right turn (South Street) for East Hoathly.	10.00m



Additional Safety Instructions

- Competitors must exercise extra care when turning LEFT just after Start and at the Boship roundabout
- **No 'U' turns after finishing or riders will be disqualified** – after finishing, competitors MUST continue to The Shaw roundabout and take second exit (RIGHT) to return to Event HQ at East Hoathly Sports Pavilion.
