<p>OS References: Sheet 161 - Start SO392054; Finish SO387088.</p> <p><b>START</b> on unclassified road approx 2 miles southwest of Raglan rbt sp "Gwehelog, Usk" in spacious field entrance just south of double bend warning sign (triangle). (This is about 200 yards south of red brick Ton Cottages NP15 2HS on the left and the second turn to Llandenny opposite them on the right.)</p> <p>Proceed northeast to Raglan rbt (1.98 miles) where take 2<sup>nd</sup> exit (<b>O</b>) on unclassified road (old A40) sp "Clytha 3" to begin 1<sup>st</sup> circuit and proceed to junction with A40 at Hardwick rbt (9.90 miles). Take 1<sup>st</sup> exit left (<b>O</b>) onto A40 back to Raglan rbt (17.48 miles). Repeat circuit 32.97 miles; repeat circuit 48.46 miles.</p> <p>After beginning a 4<sup>th</sup> circuit <b>FINISH</b> at drain cover recessed into verge 20 yards west of Raglan Garden Centre entrance 50.04 miles</p>

However Cycling Time Trials Regulations provide that a copy of the form should be sent to the Secretary of each District Council in whose area the event passes to arrive not less than <b>42 days</b> before the date of the event. It is recommended that the Notice should be sent to the Chief Officer of Police at this time rather than immediately prior to the expiry of the statutory 28 days.
