<p>OS References: Sheet 161 - Start and Finish SO 308121</p> <p><b>Start</b> on A40 at first lay-by approx half a mile east of Hardwick rbt; 39 yards west of post 13/1, at concrete joint marked 74. Proceed eastwards to Raglan rbt (7.060) where straight on for half a mile to bear left onto unclassified road (old A40) and proceed towards Monmouth to junction with A40, one mile west of Mitchel Troy (12.080). Turn left <b>(O)</b> to rejoin A40 westbound. After passing Monmouth Services, take 1st slip road left and continue westwards on A40 to Raglan rbt (17.166) where straight on to Hardwick gyratory (24.766). Circle gyratory <b>(O)</b> and take A40 dual carriageway eastbound past the Start and back to Raglan rbt (31.811). Repeat as before (Mitchel Troy 37.831) (Raglan rbt 42.917) to <b>Finish</b> in 8th lay-by (opposite start) at post marked 13/1. 50.030 miles.</p>

However Cycling Time Trials Regulations provide that a copy of the form should be sent to the Secretary of each District Council in whose area the event passes to arrive not less than <b>42 days</b> before the date of the event. It is recommended that the Notice should be sent to the Chief Officer of Police at this time rather than immediately prior to the expiry of the statutory 28 days.
