Proceed on A479 north-west up a gradual climb through Cwmdu, Waun Fach to top of climb at Pengefford (1084 ft). Continue downhill on A479 through a series of sharp bends for approximately 4 miles to Talgarth roundabout (9 miles). Encircle roundabout taking 4th exit to on A479 to start long climb through a series of bends to Pengeffordd. Continue on A479 on long descent through Cwmdu (take care), Tretower to Finish in small layby alongside double farm gate and 200 yards before junction with A40 at Nantyyffin Cider Mill (20.4 miles) Event HQ; Crickhowell Community Sports Centre, New Road, Crickhowell. Powys NP8 1AW allowing plenty of scope for warming up and warming down after the event retrace outbound route alongside double farm gate and 200 yards before junction with A40 at Nantyyffin Cider Mill</p>			<b>RS23</b>
