Numbers and signing on sheet will be at the event headquarters at Dial Post Village Hall (RH13 8NJ). The hall will be open from 5am. Covid restrictions mean that no gathering may take place inside the hall, however there is some outside space for riders to recover after, so bring a chair to sit on.

Warnings:

CTT regulations require the compulsory use of helmets for the under 18's. In the interests of your own safety, Cycling Time Trials and the event promoters strongly advise all competitors to wear a hard/soft shell helmet that meets internationally accepted safety standards.

CTT Regulation 14 now requires that "No competitor shall be permitted to start either a Type A or Type B event unless such competitor has affixed to the rear of their machine a working rear red light, either flashing or constant, that is illuminated and in a position that is clearly visible to other road users."

The onus is on the rider to comply with this rule. There will be no warnings or policing at the start.

Competitors are requested not to warm up on the course after the first rider has started.

Competitors must not use ANY audio equipment except prescribed hearing aids.

NB A competitor in breach of this regulation shall be disqualified.

NB Competitors must not use a mobile phone while mounted on their machines.

District Regulation: No Vehicles, except those of the Timekeeper and Event Officials, shall be parked in the vicinity of the start and finish areas.

Riders, when approaching the finish, you MUST keep to the left of the line marking the off slip into Grinders Lane and MUST start to noticeably decelerate immediately you cross the finish line and MUST pass the entrance to the Garden Centre before returning to the A24 to cross to the changing rooms. ON NO ACCOUNT must the Garden Centre be used for turning.

Official Observers will be stationed around the course.

I would think that it takes approximately 10 minutes to ride to the start from the HQ, so allow enough time.


