(0.87 miles). Take 1<sup>st</sup> exit left onto A40 towards Raglan rbt.</li> <li>➤ Encircle Raglan rbt (8.7 miles) taking 5th exit left onto A40 westbound back towards Abergavenny.</li> <li>➤ After A40 bends from west to north-west, Finish at Joint #273 at beginning of next lay-by, 15.011 miles.</li> </ul>

<b>NOTE TO PROMOTING SECRETARY:</b> After completion by the Promoter this form must be lodged with each appropriate Chief Officer of Police <b>within whose area any portion of the route traverses</b> , not less than 28 days before the date of the event. However Cycling Time Trials Regulations provide that a copy of the form should be sent to the Secretary of each District Council in whose area the event passes to arrive not less than <b>42 days</b> before the date of the event. It is recommended that the Notice should be sent to the Chief Officer of Police at this time rather than immediately prior to the expiry of the statutory 28 days.
