**Q10/30 Course Details:**

Start at eastern end of 1<sup>st</sup> drain in May Street, just before entrance to Southern Water Services Depot (TR208673).

Proceed via service road to join A299, continue on A299 to St Nicholas at Wade RAB, take 3<sup>rd</sup> exit to Monkton RAB (5.472 miles).

Turn and retrace A299 to finish west of the Roman Galley PH on slip road to Chislet, 4 yards before last LP FUV010 before turning left on slip road (TR225676).



**HQ to the Start:**

Turn right out of the car park, down the hill to the 'T' junction, turn right and continue for four miles to reach the start.

**Allow at least 20 minutes to get to the start from the HQ. It is 4½ miles away**

**Finish to the HQ:**

After finishing proceed on the A299 for approx 1 mile, turn off at sign for Reculver, then left at T junction to return to HQ.

**Use of Turbo Trainers & Rollers:**

South Eastern Committee meeting (January 2019) offered updated guidance regarding the use of Turbo Trainers & Rollers at event HQ's:

"For events starting in the morning no rider is to use a turbo trainer or rollers in the HQ parking area or adjacent roads that are within 50 metres of a domestic property.

**Anyone failing to comply with this restriction will risk disqualification"**

**Rider Safety:**

It is in the interest of those involved in facilitating this event and all competitors, that this event is managed in a manner that makes it as safe as practicably possible for all competitors.

**PLEASE READ**

**IT IS STRONGLY ADVISED**

**Helmets:** A 'Hard Shell' helmet that complies with current Safety Standards (EN1078), **IS** worn by all competitors when racing at this event.

**Lighting:** A working rear light, either flashing or constant, **IS** fitted to the machine in a position visible to following road users and is active whilst the machine is in use.

**All competitors under the age of 18 MUST wear a 'Hard Shell' helmet**

It is the responsibility of each individual competitor, working in partnership with the event organisers & marshalsPD, to make their racing experience as safe as is possible.

Note:

- No warming up on the course once, or 'U'-Turn in the vicinity of the 'Start' is permitted once the race is in progress.
- Take care when entering the main A299 from the 'Start' slip road, the road surface is poor & riders will be filtering on to a busy dual-carriageway.

**Signing IN & OUT:**

All competitors MUST sign against their name, on the 'Signing IN Sheet' when collecting their allocated number & sign 'OUT' on the same sheet, when they have finished their race & returned their number.

Failure to do so will result in a DNF & their finish time omitted from the official results.

**NOTE: Re MARSHALS & RIDER SAFETY**  
**(Please Read)**

The race 'Marshals', will safely position themselves on the course so that they are clearly visible to both riders / competitors & other road users.

It must be stressed that their role is to facilitate & where practicable, to keep riders safe, however any personal risk taken by a rider falls to them.

Marshals have no power to stop or control road traffic & at no time will they place themselves in an unsafe, dangerous position.

Any rider that takes undue risk & causes road traffic to take avoiding action will be reported to the 'Event Organiser' & may risk disqualification from this event.

All 'Riders' should note that 'Event Safety Concern' forms are available for comments and suggestions, which could significantly promote safety & improve this event.
